# Tory launch gambit to stay in the EU

ory Prime Minister David Cameron has sought to dampen down growing popular opposition to EU membership by promising a referendum in about five years time after the Europhile party leadership has negotiated a 'new settlement'.

"And when we have negotiated that new settlement, we will give the British people a referendum with a very simple in or out choice," he said.

This manoeuvre is meant to garner EU-critical votes at the next election and allow the Tories to campaign alongside the Lib Dems and Labour leaderships to stay locked into the EU permanent austerity machine.

While euro fanatic Lib Dem leader Nick Clegg huffed that EU renegotiation "is not in the national interest" and Labour leader Ed Miliband confirmed that "we don't want an in-out referendum" both know Cameron's gambit is designed to maintain unity among the political elite.

The Conservative Party has always been a supporter of the creation of an undemocratic European superstate dominated by corporate capital. Cameron, John Major and even Margaret Thatcher all enthusiastically

signed the various treaties designed to bring this about.

When Thatcher belatedly tried to reverse this long-held policy and opposed Britain's membership of the European Exchange Rate Mechanism and the Euro, she was removed in 1990.

The reality today is that Cameron cannot make any meaningful changes to EU structures without the support of all 27 member states, a deliberately impossible task.

Miliband's craven support for the EU will also further alienate working class voters as Labour is losing votes to UKIP as much as the Tories are and it is not good the labour movement sticking its head in the sand.

Utopian dreams about the EU and the cargo cult known as social Europe will not prevent the damage done by EU treaties that remove real democracy from voters and hands power to rapacious corporate capitalism.



# Germany in Latin America

Prior to the German Chancellor's visit to Latin America at the end of January, government advisors in Berlin were predicting that the continent faces a "historical turning point". According to an analysis by the German Institute for International and Security Affairs (SWP), it can be expected that the "resignation" of the seriously ill Venezuelan President Hugo Chávez would provoke serious upheavals - not only in Venezuela. Cuba also could be seriously affected, due to its dependence upon Caracas.

Without Chávez, Alba, the international alliance that is resisting US-American and European hegemony on the continent, would be lacking a leadership, capable of achieving its objectives, says the SWP which sees a window of opportunity for Berlin. It can be expected that in a reshuffle, Brazil would be able to reinforce its standing in South America.

In Berlin, this is seen as advantageous, because Brazil is one of Germany's most important Latin American allies. In addition the SWP ways this would open up new opportunities for Berlin in the "promotion of democracy" and political "counselling" in Latin America. (German Foreign Policy 17.1.13)

#### **CAEF Press statement 23.1.13**

Cameron's statement on EU membership does not address the acute problems which the peoples of Britain face. To dangle the carrot of the prospect of a referendum sometime maybe in the future is simply talk for his: diminishing numbers of supporters to win the next General Election; and to appease US objections to Britain opting out of the EU.

The major objectives of those opposed to disastrous EU membership must be to reestablish the right to self-determination, national independence and democracy. This must include controls on the movement of capital, services, goods and labour.

The labour movement must be won to readopt the policy of Britain's withdrawal from the EU instead of holding onto the

apron strings of the financial sector which includes the banks that caused the economic mess Britain faces. Cameron and Osborne have repeatedly stated they want to protect the City of London as the financial centre of the EU from which austerity policies stem.

That requires the election of a government to stand up to the financial sector and transnational corporations by exercising sovereign powers and legislation on behalf of the vast majority of people in Britain. This to include polices to trade across the world, including the continent of Europe, with an economy based on manufacturing to guarantee jobs and prosperity for the future of Britain.

# Prum Treaty DNA and DVLA


The objective of the Prum Treaty is for each EU Member State to grant each other access rights to their automated DNA analysis files, automated fingerprint identification systems and vehicle registration data which includes owners of vehicles.

This little known treaty was originally signed by Schengen Member States back in 2005. The European Commission turned this into EU wide legislation in 2008 with agreement of the New Labour Government. This legislation is supposed to be in place by 2014 and Britain has been threatened with £millions fines by the European Justice Court for none implementation.

A Commission report admits "A considerable number of member states consider that the matching rules, in particular for DNA data, are not fully satisfactory and should be designed...so as to avoid matches that are ...false...".

The thought of police forces across 26 other Member States having access to DVLA data is mind boggling where one wrong digit could result in the use of the European Arrest Warrant and a knock at the door and transportation to somewhere else in the EU.

This is EU legislation that must be stopped and Parliament needs to do just that.



#### EU-Passenger Name Record (PNR)

On 9 January the Commission published a call for proposals for projects that at the very least see the "establishment of a unit in the Member State which will be responsible for the collection, processing and retention of PNR data," and preferably also the actual ability to collect, store, process and share the data.

This data would be collected at air and seaports.

This has been described by Green MEP Jan Philipp Albrecht last year as part of the "ever-creeping drive for more pervasive retention and analysis of private data and big brother-style surveillance."

The scheme will be financed by the EU and planned to commence in 2014.. It is another piece of EU legislation that parliament can stop.

# Lessons from 40 years in the Common Market

t is 40 years since Britain, Denmark and Ireland joined the Common Market under the premiership of Tory Edward Heath in 1973. This was the time when a small number of Labour MPs voted against Labour's policy of opposition to EEC membership. The date marks the time when the ruling class turned its' back on the nation-state of Britain.

This followed a period when direct imperialism of the British Empire was changed to neo-colonialism. Britain joined five other broken empires in a temporary alliance of the EEC. The US had taken over the military machine that guarded vested interests around the world in place of Britain. Since then Britain has relied on the US military-industrial-complex.

US foreign policy was to encourage all concerned, especially France, for Britain to become a member of the EEC in an economic and military bloc in the 'cold war' against the USSR and prevent the spread of socialism. Today, as shown on page 5, the US policy over Britain in the EU has not changed.

Labour Party and TUC policy was for withdrawal from the European Community at the 1975 referendum when the promise was "jobs for the boys". This policy position was held until Commission President Jacques Delors sold the Social Charter to un-mandated delegates at the 1988 TUC Congress as well as the Danish and Irish TUCs. The 'bargain' struck was the 'Social Charter' in exchange for support of European Union and the 1992

Maastricht Treaty which included strict criteria for the single currency and single market.

The criteria for the single currency included severe limits on public sector spending and government borrowing. Although Britain did not join the euro, successive governments have applied these criteria so that we are in the penultimate stage of adopting this disastrous currency. Stemming from the practical side of these criteria were the PFI and PPP schemes which now blight and burden the NHS with paying out vast sums of money. That is the 'excuse' behind the closure of hospitals and their blatant transfer to the private sector.

The single market is a truly free market defined by the 'free movement of capital, services, goods and labour'. These are the conditions that the TNCs and banks strive for. This is why they want an end to the powers of the governments of nation states to legislate in these areas that provide for cheap labour to be moved around within the EU, for capital to seek out and move jobs, factories and whole industries to maximise profit.

Arising out of the Social Chapter tucked in the back of the Maastricht Treaty, Social Europe has been exposed as a bad bargain and a con, made clear by appalling and deteriorating conditions faced by workers in the eurozone member states of Greece, Spain, Portugal and Ireland.

The major battle for the foreseeable future is to focus on and stop the

relentless attack on nation-states by transnational corporations and banks represented by the millionaire Cameron cabinet. An end has to be brought to the current situation where Britain is dictated to by the financial sector and TNCs and banks. It is they who press for all the privatisation and destruction of the NHS, state education system. That is done in line with countless EU policies, directives and legislation that over-rides parliament at Westminster and democratic accountability at national, regional and local levels.

The call to work harder and tighten belts in order to compete and win the race in the global market must be spurned. This is simply an invitation for workers to compete in the latest form of imperialism which is covert and called 'globalisation' to distract the unwary.

Whether or not there is to be a referendum in five years time the labour movement must be won to readopt the policy of Britain's withdrawal from the EU instead of holding onto the apron strings of the financial sector, banks and Tories which represent them, which caused the economic mess Britain faces.

# Demands the labour movement must make

Whilst Britain is in the EU it has common policies and legislation imposed which have:

- Taken away the sovereign powers from Britain and the right to self-determination and national democracy
- Reduced national, regional and local democracy and accountability which includes all forms of practical, formal and informal democracy
- Provided for the free movement of capital, goods, services and labour where national controls are not permitted
- Has created mass unemployment across the EU including Britain and especially amongst young people

The EU and its institutions are based on legislation and policies to remove all the controls which have been put on capitalism and to let it rip. The EU seeks to destroy all social safeguards and rights that in some cases have taken centuries to build.

An important part of this deliberate destruction is the austerity policies being carried out which are common across all EU Member States including Britain and blatantly applied in the eurozone. The objectives of these policies are to:

- Provide a pretext to reduce public debt which was largely produced by the financial sector
- Increase exploitation and therefore profits by pressing down incomes and wages and hours worked
- Privatise what is left of the public sector including the NHS and state education
- Provide a massive transfer of wealth to

the rich from the middle and working class sections of society.

There *is* an alternative to the austerity, and mass unemployment: and attacks on the public sector:

- Cease making  $\pounds$  billions payments to the EU Budget
- Place controls on the movement of private capital
- End over-dependence on the financial sector
- Encourage investment in manufacturing, hi-tech industries and the infrastructure to include
- Investment in the existing and expanded railway system with a high speed rail network all under public ownership and accountability
- Create a public national water network
- Return to public ownership and accountability the gas and electricity industries
- Conversion of defence industry into socially useful production
- Trade with the world and not primarily with the EU


The key to achieving the alternative is to make it clear in the labour and trade union movement and growing young people's protest movement:

#### **EU News**

#### Czech Republic

The President of the Czech Republic, Vaclav Klaus has come to the end of his term of office. Mr Klaus delayed as long as legally possible before he signed the Lisbon Treaty another name for the European Constitution. #### **New Treaty**

Germany and France will table joint proposals deeper eurozone integration by May and are "working closely" to get a deal on EU's seven-year budget next month. The two leaders agreed this on 22 January during Franco-German festivities.

They were celebrating 50 years of the Franco-German Elysee peace treaty. The Bundestag made room for double its normal capacity to host a joint session of French and German parliaments.

These double-page spread Fortune magazine's list, 20 European portrayals range from the nationstates of the world and populations change. There are around 200 nation-states in the world and this is the basis of all the diagrams.

Included is obesity data which indicates that 1.5 billion adults are overweight, a figure that has doubled since 1980. Two thirds of the world's population live in countries where there are more deaths from excess weight than undernourishment. An obvious common sense fact given is that poor diets of those on low incomes fuel obesity.

The diagram titled 'war-lords, gang-lords and militias' show that most of these are active in the former European colonies, or, where the US has interfered on the pretext of tackling the drug trade.




