Trade unionists Against the EU will take message to TUC

rade unionists Against the European Union (tuaeu.co.uk) will take the fight to get out of the EU prison house to delegates at a fringe meeting during the Trade Union Congress meeting in Brighton.

Labour MP Kelvin Hopkins, will promote his new pamphlet The EU: a view from the left, points out that the EU is anti-democratic, anti-socialist and, as long predicted, is in a process of economic decline.

He writes that the Tories largely support the EU because it is precisely a force for neoliberalism and privatisation.

TUAEU spokesman Brian Denny will make clear those in the labour movement that currently support EU membership will not be claiming that 'social Europe' will protect workers from Tory attacks including its vicious Trade Union Bill. That is largely because 'Social Europe' has died a very quiet and strange death.

The EU is now imposing zero-hours contracts, casualisation and poverty pay as well as smashing up collective bargaining across Europe as part of its structural adjustment programme known as austerity.

He will point out that even the European TUC, which interestingly recently campaigned for a 'Yes 'vote in the Greek referendum for more austerity, openly admits that "cuts in salaries, cuts in public services and weakening collective bargaining rights are all on the agenda".

Helle Hagenau of No to the EU in Norway, will warn that the EU was currently negotiating secret trade deals which institutionalise irreversible mass privatisation of public services, lower safety standards and abolish tariffs for the world's largest corporations.

Helle will emphasise that these treaties, currently known as Transatlantic Trade and Investment Partnership (TTIP) with the US and CETA with Canada, create secret courts that allow transnational corporations to sue nation states for huge sums of money.

Trade union lawyer John Hendy will make clear that the EU's neoliberal employment model openly calls for wages to reflect productivity, which means cutting wages even further allegedly to compete with the 'core' high-investment economies of France and Germany.

This has sparked unprecedented levels of unemployment particularly in socalled 'peripheral' countries.

The European Commission, IMF and the European Central Bank now directly intervene in national wage negotiations in Ireland, Greece and Romania in order to weaken collective bargaining.

And it's working, for instance previously in Romania 98 per cent of workers were covered by collective agreements today that figure is around 20 per cent.

Brian Denny will warn that a new form of EU colonialism was developing whereby wealth was being directly transferred from the periphery to the core particularly in Greece and now Ukraine.

This colonial transfer of capital takes the form of interest payments on ever rising debt, creating permanent







The Gauntlets are down on EU membership, TTIP and refugees

he EU is in yet another mess following hard fast behind the unresolved euro-crisis. Now the EU has to square up to the consequences of interference in the Middle East by military forces and foreign policies from within the EU including Britain. Common sense speaks loudly about the reasons for the mass migration of refugees and asylum seekers attempting to reach a safe haven and work in the EU. War torn Syria and all the misery and loss of life need not have happened if the British and other governments had supported the sovereign government of Syria.

It is ironic that the southern EU Member States, especially Greece, who are subject to the euro crisis, are expected to solve the immediate problems they face caused by thousands of refugees. This is compounded by the abandonment of a long standing EU policy on free movement in the Schengen area. This area includes non-EU Members States - Norway and Switzerland.

A further irony is that even with her short period of terrible history, Germany has stated she will welcome and take 800,000 refugees largely from Syria. Even German football fans have waved banners welcoming the refugees. Germany did not take part in bombing Libya. Britain and France were largely responsible for that awful crime against humanity which followed the devastation wreaked on Iraq. This created a vacuum allowing IS/ ISIS to step in and carry out what are tantamount to fascist acts and policies beyond comprehension.

Britain has always been a haven for refugees and asylum seekers and should continue to be so in a humane manner. Britain must take on its share of responsibility for those



seeking a decent life and allow these people the dignity of human beings.

TTIP and ISDS are further potential crises fraught with umpteen problems for labour and trade union movements and workers. The Referendum on EU membership must be used to stop TTIP which is planned to override governments, parliaments and electorates. TTIP is an extension of the EU which would bolt on the EU's single market on to the US market. It is plainly obvious that if one is against TTIP you cannot be pro-EU as that would be a complete contradiction.

CAEF fully supports and is part of the Trade Unionists against EU (TUAEU) which has made TTIP top of the agenda. CAEF is working in conjunction with the *Morning Star* by providing the paper with material including a weekly column 'How the EU Operates' by our CAEF Secretary. The Star is carrying plenty of material on the EU and TTIP and is the only daily newspaper to do so with full commitment and in any depth. This is part of the growing movement within the No! camp to both the EU and TTIP. Despite all the evidence the TUC and most trade unions against TTIP still retain the contradictory policy which supports Britain's EU membership.

Meanwhile the euro crisis gets worse as was bound to happen in the attempt to tie together EU Member States into a euro-zone. The major problem is that the European Central Bank controls interest and exchange rates. These key economic levers should and must eventually reside with national governments to control their economy. Greece has been turned into a colony within the EU as everything is turned over to privateers and run from outside this country. The Syriza government has turned out not to be left wing at all but at the beck and call of the eurozone masters and has gone against the position and decision of its own electorate. These masters take the form of the ECB, European Commission, IMF and banks in Germany and France. The latter would be in serious difficulties, even bankrupt, if Greece dared exit the eurozone. This is why proposals are being tabled to have a government of the eurozone and all that goes with it.

It is time for Britain to get out of the EU and withdraw from the crises that are erupting from the attempt to bring about a superstate and Euro-federalism. Part of this can be achieved by obtaining as big a No! vote as possible.

Ireland

More than 80,000 people took to the streets of Dublin at the weekend to march against EU-imposed water charges.

The huge demonstration was the fifth major protest against charges being levied by Irish Water, which began in April, and was organised by umbrella campaign group Right2Water.

Charging people for water was a condition of the 2010 "bailout" agreement imposed on Ireland by the "troika" -EU, IMF and European Central Bank — that has since presided over the cuts and privatisations in Greece.

Marchers carried banners reading: "It's your water, it's our water. It's not their water to sell" and "Water is a human right."

Irish Congress of Trade Unions president John Douglas said the water bills were "just the tip of the austerity iceberg."

Civil and Public Services Union activist Dee Quinlan said the demo was "to show that we will no longer pay for the sins of the property speculators, top-tier bankers, centre-right politicians and their pursuit of the policies of austerity.



"If we accept these charges, we are then in acceptance of the inevitable privatisation of water in this country.

"And then we need to change the type of society we live in to one based on equality, fairness and solidarity rather than one based on greed and exploitation."

EU Commission's blatant and illegal interference

The European Commission is interfering in the internal affairs of Britain. There is already clear a indication the Commission will poor money, material and misinformation into every nook and cranny to obtain support for Britain remaining an EU Member State.

The Commission has no power or right to intervene as the subject of the referendum is whether or not Britain annuls an EU Treaty.

It is significant that Denmark is holding, at very short notice, a referendum on 3 December over whether or not to join the EU's Justice and Home Affairs Policy which was previously an intergovernmental arrangement.

No doubt talks at the EU level and between Britain and Denmark have deliberately put the Danish referendum before one due in Britain. A win by the Danish government will be used to persuade voters in Britain to stay in the EU.

Other referendums that Denmark will face, which currently like Britain, is outside the eurozone includes joining the EU Banking Union and Military aspect of the EU.

In time Britain will be pressed to abandon the case by case opt-in of the EU Justice and Home Affairs policy and could be part of the horse-trading between Cameron and the EU.

great deal is often made about the supposed improvements to employment rights brought about by Britain's membership of the European Union. This summary aims to show that, on the contrary, most of the basic laws were passed by Labour Governments during the 1970's, with trade union support. During the following decades, the EU refined some of this legislation into Directives and has laid claim to be progressive, in an attempt to keep workers and trade unions passive and quiescent. Yet the EU has not lifted a finger to change the anti-trade union legislation in Britain, kept in place by both, Tory, New Labour and Tory/LibDem Coalition Governments. A further attack on union rights and right to strike is planned by the Tory Government.

Indeed, working people across the EU are now faced with attacks on established trade union collective bargaining of terms and conditions, social dumping in pursuit of profits, enforced austerity and mass employment in some countries and what amounts to Thatcherism on a European scale. As the European TUC

General Secretary Bernadette Segol said in June 2011 "cuts in salaries, cuts in public services and weakening collective bargaining rights are all on the

agenda". The EU is not "Europe" but a political construct imposed on the peoples of Europe. It is time to leave and to vote No! in the referendum.

Legislation passed by Labour Governments in the 1970's includes:

Equal Pay Act 1970 - Prohibited any less favourable treatment between men and women in terms of pay and conditions of employment.

Trade Union and Labour Relations Act 1974 - Established the Labour Party employment law programme.

Employment Protection Act 1975 - Established the industrial (later called employment) tribunals system separate from the formal courts system, Health and Safety at work Act 1974 established the basic regime for health and safety. Sex Discrimination Act 1975 - Protected men and women from discrimination on grounds of sex or marital status Race Relations Act 1976 (which built on 1965 and 1968 Acts) - Prohibited unlawful discrimination on grounds of race,

colour, nationality, ethnic origin in employment, provision of services. The Commission for Racial Equality (CRE) was established.



Some EU Directives subject to later interpretation by the ECJ include

Right to paid annual leave four weeks -The ECJ ruled against Britain on this in 1996

Maternity and Paternity leave - Through Equal Treatment Directive

Maximum 48 hours working week (with opt outs) - Through the Working Time Directive. However, in France, 35 hours a week had already been achieved through trade union and Government action. Collective Redundancies Directive and



Acquired Rights Directive - Applicable when a business is sold on.

> European Works Councils (for large companies) - Gives rights to "consultation" but does

not stop job losses across the EU through closures or moving to cheaper labour areas.

Posted Workers Directive - see references to ECJ cases below.

Temporary and Agency Workers Direc-

tive - This is not primarily intended to protect non-permanent labour but to make such activity the norm. The Norwegian TUC (Norway is outside the EU) held a general

strike in 2012 against their Government's planned implementation of this Directive into national law and the social dumping that would ensue. Norwegian law in this area is some of the best in the world.

EU foundation and the role of the European Court of Justice in interpreting the laws

The legal basis for the EU can be traced back to the 1957 Treaty of Rome which enshrined the creation of a single market with four fundamental freedoms of movement of goods, persons (labour), services and capital. The role of the European Court of Justice (ECJ) is to police this free market and this must necessarily involve attacking national legislation protecting workers and trade union rights that are in conflict with the central free trade principles. In this regard, collective action is a restriction on free movement and the ECJ has ruled accordingly. Before detailing those rulings, it is important to recall the role of the UK Thatcher Government in pushing through the 1986 Single European Act (SEA) which established a Single European Market enshrining the four freedoms and replacing the rule of unanimity with qualified majority voting (QMV) in the Council of Ministers. The architects of this were corporate interests across the EU.

ECJ rulings that have attacked employment rights

Viking Ferries (11/12/2007) - The Fin-

nish Seamen's Union took industrial action against members being replaced with cheaper labour.



The ECJ ruled that this violated the rights of the employer to freedom of establishment and to provide services.

Vaxholm-Laval (18/12/2007) - Laval (a



Latvian company) employed Latvian workers on a Swedish contract in Vaxholm outside Stockholm that were paid much less

than within a local collective agreement.The ECJ agreed to this social dumping in the name of free movement. **Luxembourg case -** Luxembourg offered workers better conditions than in the

Posted Workers Directive. The ECJ ruled this was illegal.

Ruffert case(2008) - The ECJ ruled that a state in Germany was forbidden the right to require respect for normal salaries in public construction work

Some industrial disputes that have preceded or followed these ECJ rulings include:-

Irish Ferries company

- replaced 600 Irish seafarers with labour from Eastern Europe at considerably lower rates of pay



Staythorpe (Nottinghamshire) C new power station 2009 - GMB and Unite held many demonstrations after Alstom recruited non-UK contract labour on lower pay with 160 UK workers given notice and refused to consult properly. Alsthom also used 200 Polish workers on a project in Poland but refused to let UK workers apply.

Lindsey Oil Refinery (Lincs) 2009 - 800 local contract workers went on strike after an Italian firm brought in 250 Italian workers on lower rates.

The EU is clearly intent on using the free movement of labour, capital and services to undermine and destroy hard -won labour standards and our public services. The European TUC (ETUC) which is understood to receive 80% of its funding from the EU Commission has proposed a legally binding social protocol to safeguard workers against ECJ decisions. It is our opinion that this plea will get nowhere. The EU was not set up to make it easy for workers but to pursue corporate interests. It is indeed Thatcherism on a European scale as was the intention. The only rational course is to leave the EU so that each state can make its own labour laws and run its own currency and economy.

European Movement speakers shout that there must be even more competition as public services are turned over to 'franchises', a posh name for privatisation.




